 - a. President's Update:
 - Mid-Year Meeting Debrief and Report (with Ralph Valentine)
 Ralph couldn't make the meeting so Matt gave the report. NAR has put out items to focus on from Waters US Act to monetary policy. Ralph, Matt B. and Gerry O'Connell attended the Mid-Year.

It was reported at the Mid-Year that we are in a recession – leading indicator business spending declines, slowing growth in residential rents. It is growing, but controlled. Lawrence Yun expects inflation will subside. There is conflicting data – residential housing lowers?? 3% not influence, others say impacting. Office expect to stay slow. Repurposing office space into housing – detrimental to downtown. Urging people to stay on outskirts – buildings that make sense. Advocacy – NAR working on stuff with IMF....butting up against Housing issues - \$ is there. Investment RE experiencing expense ?? growth – impacting valuation. NAR budgeting 15% reduction in membership. I don't think we are going to see the same thing. Matt B. will circulate a report next month in the President message.
