- 3. Secretary's Report D. Tanguay
 - a. **MOTION** to accept the minutes of the March 2024 Board of Directors meeting. **MOTION** was **SECONDED** and **APPROVED.**

4. President's Report – Ethan Ash

- A. President's Update
- 1. Board of Director Vacancy -Larry Hirsch Resigned Term expires 12/31/24. Ethan said we needed to replace Larry. Jesse Hepler from SVN was interested. Kathy mentioned that she spoke to Jesse and he didn't commit. Kathy said that maybe we should send out a blast email to members. Bill said the approach used earlier to fill BOD positions was to look for candidates who are actively involved in committees. Matt B. echoed what Bill said. Matt B. expressed concerns about having too many people from one company on the board and that might be a good idea to have some different firms and different parts of the state. Ethan mentioned that we may always have certain brokerages who are more involved. Jeff said that we should consider affiliates in certain classes of businesses. Bill said that an Atty. Would be good possibly Laura Gandia who is an Atty. And was the Town of Londonderry Planner. She attends all the PPC meetings. Bill will approach Laura about this. Nicole would like the board to be more geographically diverse. Dave G. believes we should fill this with a REALTOR member since we are a REALTOR organization. Ethan would like recommendations for him to reach out to.

Ethan asked us to add another committee report to the agenda: Strategic Planning Committee. Ethan mentioned that Matt L. was interested in being the chair. They will chat offline. B. Office Administration Report – A. Ropes

- c) (Education) B. Jean Hiring Ripaldi to teach the CORE class on June 7th and a Risk Management class on Sept. 13th. The courses will be in Bedford.
- d) (Finance) J. Boufford

- i) (Public Policy Committee/Government Affairs) D. Garvey HB398 – same disclosures. Stripped down Housing passed Senate. OPLC option to have a dedicated staff person, but can't fill all positions. End of Lease doesn't mean the end of the lease – to define good cause – passed House, expected opposition in Senate.
- j) (NHCIBOR Cares) Laura Nesmith Discussed who is looking for help ...we have a war chest to deploy more funds. Does anyone on the Board on nonprofits? We are looking to use the funds. We can authorize the money through email. Golf income is dedicated towards scholarships – seek to bolster scholarships and get more recognition. Looking to put a scholarship update on the website.
- k) (Forms) B. Jean Nothing new to report.
- (NECPE: Transition to New Moody's/Catylist System) Matt L. Brian Dano connected with an agent in CT regarding ECCN (East Coast Commercial Network) which is not looking to renew the Catylist contract. Looking into the possibility of NECPE absorbing those members....someone said that they were under the impression that ECCN was with Crexi Pro, but they currently have a Catylist contract with 440 members. Ethan will have a meeting with the current President regarding the reason to change? We will have to amend our current contract with Moody's. Matt L. said that the current transition from the old platform to the new platform includes some bumps in the process. Absorbing CT and RI we might be in a better position to negotiate. Matt B said that NECPE is a money generator for NHCIBOR. NECPE Task force is test driving the system. We had a meeting last week. We want to address some of the bugs in the program before we release. The committee if putting together a list of frequently asked questions. Committee is crafting a letter and next month we should have a timeline.
